2. Terms of reference

- ii. Evaluate the pre-flood vaccination and compare it with post vaccination titration reports especially for flood prone area
- iii. Review the availability of available stock of medicine kept to cater flood
- iv. Evaluate & monitor the other measures regarding awareness and coordination of ADL & ADIO with concerned DDMAs.
- v. Review the effectiveness of monitoring tiers i.e Deputy Directors , ADLs and Divisional Directors for implementation of flood contingency plan as per government directions in letter & spirit
- vi. Review and evaluate the reporting mechanism for flood related activities to provincial flood cell at ADDRS as per performa designed by ADDRS
- vii. Report any other related issue as observed
- 3. The monitoring officer will personally visit the assigned flood prone districts and submit in detail report along with recommendations to the secretary livestock before July 13, 2020.
- 4. The follow up meeting on the report of monitoring officers will be held on July 13, 2020.
