	ii.	If received after the time and date fixed for its receipt.
	iii.	The tender is unsigned.
	iv.	The offer is ambiguous.
	v.	The offer is conditional.
	vi.	The offer is from a firm, blacklisted, suspended or removed from the approved list of L&DD Department/ Govt. of the Punjab.
	vii.	The offer received by telegram or fax.

	ix.	The offer is for store/procurement of medicines & pesticide not confirming to specification indicated in the tender enquiry.

4		The registered firm will attach <b>call deposit @ 2% (CDR)/</b> Pay order/ Demand Draft of Estimated price <b>Rs.1600000/-</b> in the name of Officer In-charge, Livestock Experiment Station, Fazilpur, District Rajanpur as earnest money with Technical Proposal and also enclosed a photo copy of NIC.
5		Supply of the above items at the consignee end will be free of cost.
6		Contractors should be registered for all kind of taxes.
7		Original literature must be provided with quotations. Original sole distribution certificate or authority letter from the manufacturer must be attached with the quotation.
8		On the acceptance of the tender the amount @ 10% would be deposited as performance security.
9		The person signing the tender on behalf of the tendered must specify his authority, that is to say, whether he signs as the sole proprietor, Acting Managing Partner, Managing Director, Acting Director, Manager, Secretary for the firms and if so required shall have to produce copy of the documents authorizing him to sign the tender.

16	The undersigned has the right to purchase full or part of the items or ignore / scrap / reject any tender without given any reason.
17	The structure will be responsible for the free installation, demonstration, replacement (supply)
18	In the acceptance of the tender issued during the tender does not accept the validity period of the offer, the earnest money shall be forfeited and the store purchased at his risk and expenses.
19	In case the offer withdrawn, amended or revised during the validity period of other earnest money is able to forfeited
