

Any offer not received as per terms and conditions of the bid enquiry is liable to be ignored. No offer shall be considered if

- Received without earnest money.
- (ii) If received after the time and date fixed for its receipt;
- (iii) The bid is unsigned;
- (iv) The offer is ambiguous;
- (v) The offer is conditional;
- (vi) The offer is from a firm, blacklisted, suspended or removed from the approved list;
- (vii) The offer is received by telegram;
- (viii) Offer received with shorter validity than required in the bid enquiry; and
- (ix) The offer is for store not conforming to specifications indicated in the bid enquiry.
- The Purchaser reserves the right to purchase full or part or more of the store or ignore/scrap/cancel the bid.

- (b) In case the offer is withdrawn, amended or revised during the validity period of the offer, the Earnest Money is liable to be forfeited.

- (c) In case, the contractor fails to execute the contract strictly in accordance with terms and conditions laid down in the contract, the security deposited by him shall be forfeited and the store purchased at his risk & expense and necessary action will be taken according to PPRA rules, 2014.
- The buyer reserves the right to claim compensation for the loss caused by the delay in the delivery of store.
- All bids must be submitted in single stage two envelope containing financial and technical bids separately as under: -
- (i) The bid will be single packet consisting of two separate envelopes, containing separately the financial and the technical proposals;
- (ii) The envelopes will be marked as "Financial Proposal" and "Technical Proposal".
- (iii) In the first instance, the "Technical Proposal will be opened and the envelope marked as "Financial Proposal" will be retained unopened in the custody of the procuring agency;
- (iv) The procuring agency will evaluate the technical proposal in the manner prescribed in advance, without reference to the price and will reject any proposal which does not conform to the specified requirements;
- (v) During the technical evaluation no amendments in the technical proposal will be permitted;
- (vi) After the evaluation and approval of the technical proposals, the procuring agency will open the financial proposals of the technically accepted bids at a time, date and venue announced and communicated to bidders in advance, with in the bid validity period...
- (vii) The financial bids found technically non-responsive will be returned un-opened to the respective bidders;

#### SPECIAL INSTRUCTIONS

The store will be required (wheat straw) by the consignee within 15 days after issuance of the each supply order and the bidder will have to complete the supply with in this period, otherwise liquidated damages @ 2 % per month or part of a month will be levied against the price of store which the bidder fails to deliver with in prescribed period However; the bidder is required to indicate their own guaranteed earliest date by which the store will be supplied.

- The supply order of wheat straw will be issued as per demand round the year 2022-23 on frame work contract basis.
- Cash Receipt (in original) in token of having purchased the bid, must accompany the offer.
- Bid should be addressed to Director, Livestock Production Research Institute, Bahadurnagar, Okara.
- Bidder shall submit a Deposit Call @ 5% (2.55 million approximately) of amount of estimated price as a bid security in favor of the Director, Livestock Production Research Institute, Bahadurnagar, Okara.
- 5. The successful bidder will be required to furnish more @ 5% security deposit to make it total @10% of the value of contract in the form of deposit at call from scheduled bank in Pakistan in the favor of Director, Livestock Production Research Institute, Bahadurnagar, Okara before the issuance of supply order, as performance guarantee, which will remain as a performance warranty/security till the successful supply of the store.
- The bidders should indicate in their bid the complete address of the place/places where stores will be offered for inspection.
- The bidders shall enclose catalogue/leaflet/literature and other technical data, if any, in respect of store offered by them.
- The bidders should specifically indicate their income-Tax number. All the taxes applicable
  by Government will be included at any stage. Any change in tax rates will also be applicable.
- The bidder will also be responsible to pay the stamp duty at the rate of 0.25 % on the total amount of the bill where applicable.
- Any erasing/cutting/crossing, etc. appearing in the offer must be properly signed by the person signing the bid. Moreover, all pages to the bid must also be properly signed.
- 11. The quotation should be submitted on the basis of accounting unit specified in the invitation to bid.
- 12. A certificate should be given by the bidders that they will be responsible for use free replacement of store if the same is found to be substandard and or at variance with the specification given in the bid enquiry. In case a similar store offered is at variance with the specifications given in the bid enquiry, the bid must clearly identify variations in their offers. 12. Store offered of a specification superior to the one specified in the tender enquiry shall, however, be acceptable.
- 13. Both ingredients should be new, fresh and of fine quality in accordance with nutritional standards put in the tender document. The ingredients should be free from dust. The committee reserve the right to go beyond physical tests and make chemical analysis for nutrients. All the expenditures for such tests will be borne by contactor.

- The successful bidder should supply the receipt of professional tax, along with bill otherwise the bill will not entertained.
- If any document provided by the bidder found bogus strict action will be taken against him according to the law/rule.
- All the bids will be evaluated in accordance with the specifications and other terms and conditions mentioned in this tender document.
- The bidders should provide an affidavit on stamp paper (Rs. 100/- or above) that his firm

- Wheat straw must be baled with same quantity and free of any kind of adulteration like dust or any other.
- All the suppliers must submit the sale tax receipt as per rule along with bill where applicable.
